Quick and Easy Application

Simply complete the Builder's Express Program enrollment form included in this brochure or online at www.rockymountnc.gov. Return the completed form in-person to Inspections, located on the 2nd floor of the City Hall building, or by fax to 252-972-1590. Once your application is completed and returned, you will be enrolled in the Builder's Express Program and may begin submitting your building permits.

Using Builder's Express

Once you are set up as a Builder's Express builder in our system, you can simply complete the appropriate forms on our website at <http://rockymountnc.gov>. Be sure to indicate that you are enrolled in the Builder's Express Program. Your completed permit/service request forms can be sent electronically, returned in-person to Inspections or by fax to 252-972-1590. Once your forms are completed, we take care of setting up your utility accounts—no waiting in lines! You will have one point of contact with Inspections for a one-stop shopping experience. We invite all residential builders to participate in this program. Deposit requirements may apply based on the credit rating with the City of Rocky Mount. Enroll today to become a participating builder with the Builder's Express Program—your one-stop shop for services from the City of Rocky Mount!
