

- 2. SLOPES SHOWN FOR SIDEWALK-UTILITY STRIP ARE MINIMUM.
- 3. SLOPES SHOWN OUTSIDE RIGHT OF WAY ARE MAXIMUMS.
- 4. ALL RIGHT-OF-WAY SHALL BE CLEARED OF TREES AND VEGETATION THAT ARE GREATER THAN THREE FEET (3') TALL FOR A DISTANCE OF 5' BACK OF THE CURB AND GUTTER. RIGHT-OF-WAY CLEARANCE ON THOROUGHFARES SHALL BE AS DETERMINED BY THE CITY ENGINEER.
- 5. WHEN DESIGNING THOROUGHFARES, THE DESIGNER IS TO, AS MUCH AS PRACTICAL, CARRY LONGITUDINAL GRADE OF THE STREET THROUGH ALL EXISTING AND PROPOSED INTERSECTING STREETS TO PREVENT HUMPS NEAR GUTTER.
- 6. STANDARD CURB ¢ GUTTER PER STD. NO. 2.4 REQUIRED ON ALL COLLECTORS, MINOR ARTERIALS, ¢ MAJOR ARTERIALS.
- 7. STANDARD CURB OR ROLL TYPE (STD. NO. 2.4 OR 2.5) SHALL BE REQUIRED ON LOCAL AND CUL-DE-SAC STREET TYPES.
- 8. PRIVATE STREETS MAY BE REQUIRED TO HAVE C#G AT SPECIFIED LOCATIONS ALONG THE STREET AS DETERMINED BY CITY ENGINEER.

MINIMUM ASPHALT SECTION:

3" SF 9.5A SURFACE COURSE (ASPHALT INSTALLED AS 2-1.5" LIFTS) OVER 8" CABC OVER

APPROVED SUB BASE

*MINIMIUM PAVEMENT CROSS SECTION SHALL BE BASED ON THE ACTUAL SOIL CONDITIONS. PAVEMENT DESIGN THICKNESSES MENTIONED ABOVE ARE MINIMUMS.
